On 11-12 October the 51st edition of SHADE (Shared Awareness and Deconfliction Conference) took place in Manama, Bahrain. EMASoH was invited to the conference and Operational Commander Vice Admiral Slaars presented Operation Agenor alongside Atalanta and Combined Maritime Force Commanders.

SHADE is a yearly recurrent international forum, hosting more than a hundred of various key players in the maritime sector. The main topics of the conference were maritime security issues in the Western Indian Ocean.

Reassuring merchant vessels

One of the main objectives of Operation AGENOR is to reassure merchants vessels that cross the Strait of Hormuz. Reassurance can be provided by accompanying these vessels and making EMMA-calls (EMasoh-MAnoeuvers) to ships located in the area. In early October we released a one-minute video highlighting the way in which EMASoH aims to assist the merchant shipping in the Strait. The video is featured on ALINDIEN's Instagram and X channels.

Visit to Norwegian Embassy in Abu Dhabi, UAE

On October 26th EMASoH paid a visit to the Norwegian embassy in Abu Dhabi, United Arab Emirates. We had the privilege of meeting with Norway's Ambassador to the U.A.E., His Excellency Olav Myklebust and his staff.

During the meet AGENOR Force Commander, Rear Admiral Mauro Panebianco, presented the fundamentals of EMASoH and elaborated on Operation AGENOR, the military pillar of the initiative. NCAGS (Naval Cooperation and Guidance for Shipping) then gave an in-depth view of the Norwegian merchant shipping fleet that operates in the Gulf region and crosses the Strait of Hormuz daily.

Norway has the third largest merchant shipping fleet out of all the EMASoH countries. On average, 64 Norwegian merchant ships of interest (ships under either Norwegian flag or beneficial ownership) sail within the EMASoH Voluntary Reporting Area (VRA) every day. Most of them are tankers and containerships.

Every month 130 Norwegian ships of interest transit the Strait of Hormuz.

We would like to thank His Excellency and staff for having hosted us at the Norwegian embassy. It was a fruitful visit, and a valuable opportunity to share knowledge.

EMASoH Voluntary Reporting Scheme (VRS)

Merchant vessels are invited to participate to our Voluntary Reporting Scheme. Voluntary reporting improves the cooperation and guidance that EMASoH can provide to those ships. Voluntary reported ships are also prioritised for possible accompaniments with EMASoH's naval assets and reassuring calls with naval and aerial assets.

Before entering the Voluntary Reporting Area (VRA), 48 hours in advance, or as soon as possible:

- ✓ inform EMASoH about the timing of your intended entry and exit of the VRA;
- ✓ confirm the planning 6 hours before entering and share possible changes to the journey planning;
- ✓ report any suspicious behaviour to the coast guard of the coastal state and to EMASoH.

Reporting to EMASoH's VRS is currently done through email. To make the reporting process more convenient and structured for seafarers, we are developing and testing an alternative method: a tool on the EMASoH website that would also be convenient for other operational scheme in the Indian Ocean.

The tool allows the user to send all required information directly to NCAGS (Naval Cooperation And Guidance for Shipping) and therefore it will reduce the workload for the master. We are working to share this information among other maritime security actors operating in the area.
